Notice for admission to BDS course against vacant seats for the academic session 2017-18 in Private un-aided Dental Colleges of the State of Himachal Pradesh on the basis of merit of NEET-UG-2017

In pursuance to the orders passed by the Hon'ble Supreme Court of India on 05-07-2017 in Writ Petition (Civil) No. 76 of 2015, it is hereby notified to all concerned that for filling up the vacant seats under State/Management Quota (category-wise) in Private Dental Colleges of the State of H.P. after exhausting the merit list especially for management quota seats as notified on 15-07-2017 by the H.P. University, the applications from the interested eligible candidates are invited on the prescribed application form as uploaded on the University website www.hpuniv.in&www.hpunic.nic.in along with photocopies of relevant documents as mentioned in the counselling prospectus issued by the H.P. University uploaded on the University website who qualified the NEET-UG-2017 which must be submitted by the candidates by hand in the office of the Assistant Registrar (Entrance Tests) H.P. University, Shimla-5 on 08.09.2017 upto 11:00 AM, beyond which no application shall be entertained. The said application should be accompanied with counselling fee of Rs. 1600/- for General & other categories and for Rs.800/- for SC/ST categories in the shape of bank draft to be drawn in favour of the Finance Officer, H.P. University, Shimla. The MOP UP round of counselling through Centralized Counselling Committee for filling up the said vacant seats will be held on 8-09-2017 at 3:00 P.M. in H.P. University Auditorium with the condition that the interested candidates for seeking admission to BDS course under State/Management Quota against vacant seats in private dental colleges, candidates are required to deposit the 50% amount of tuition fee in cash and remaining amount of fee along with other dues shall be deposited in the colleges concerned on 9-09-2017 & 10-09-2017. The original educational certificates of the candidates allotted seats are also required to be deposited with the representatives of the aforesaid colleges. Tuition fee for private Dental Colleges for the academic session 2017-18 is as under :-

For State Quota seats: Rs. 73,000/- per student per annum For Management Quota seats: Rs. 2, 50,000/- per student per annum Other charges and Hostels charges are extra.

Note:.The candidates those attended MOP up round of counselling held on 29.8.2017 and are in the waiting list for admission to BDS course under state quota in private dental colleges may also report for the said counselling giving them first preference including those already admitted under management quota in order of merit. The candidates (H.P.Bonafide) already admitted to management quota are also required to attend the counselling. if they want shifting under state quota seats for another colleges in order of merit. The vacant seats, if any, of H.P. Govt. Dental College, Shimla will also be filled up during the said counselling from the wait listed candidates of MOP up round held on 29.8.2017 for which list will be uploaded on the University website on 6.9.2017.
