**Notice for filling-up of vacant /unfiled PG (MDS) seats for the academic session 2017-18**

It is for the information of all the concerned that after exhaustion of state merit of NEET-MDS -2017 during the 1<sup>st</sup> round of Centralized Counselling held on 10.4.2017, a number of PG(MDS) seats remained unfilled in Private un-aided Dental Colleges of the State ( under 50% State quota as well as 50% management quota). In order to fill-up the unfiled /vacant seats in the private un-aided Dental Colleges of the State, applications are hereby invited from **NEET-MDS-2017** qualified candidate on plain paper mentioning therein full particulars i.e. Name, Father's name, category, date of birth, name of domicile state, **NEET –MDS-2017** Roll No. & Marks etc. along with photocopies of relevant documents as mentioned in the counselling prospectus issued by the Department of Medical Education & Research, Himachal Pradesh and available on the H.P. Govt. Dental College and DME & R, H.P. website [www.hp.gov.in/hpdmer](http://www.hp.gov.in/hpdmer) and [www.hpgdcshimla.org](http://www.hpgdcshimla.org). The application must reach in the **office of Principal, Himachal Pradesh Govt. Dental College, Shimla –cum-Member Secretary Counselling Committee on or before 25.5.2017 upto 5:00 PM** beyond which no application shall be entertained. The counselling through Centralized Counselling Committee for filling up the said vacant seats shall be held **on 29.5.2017 at 11:00 A.M. at H.P. Govt. Dental College, Shimla in order of merit** with the condition that the interested candidates for seeking admission to MDS course under State/Management Quota against vacant seats in private Dental colleges are required to deposit the token amount of tuition fee in cash Rs.50, 000/-(Rupees fifty thousand only) and remaining amount of fee alongwith other dues shall be deposited in the colleges concerned **on 30<sup>th</sup> & 31<sup>st</sup> May 2017**. For filling-up of vacant /unfiled seats, preference will be given to the candidates who are graduates (BDS) from the Dental Colleges situated in the State and Bonafide Himachalies who have done BDS from any institute recognized by the DCI. The detail of vacant /unfiled MDS seats is available in aforementioned website.

The existing Fee structure for MDS course in private un-aided Dental Colleges is as under:-

For 50% State quota seats : Rs. 2.50 lacs per student per annum

For 50% Management Quota: Rs. 6.50 lacs per student per annum
